

## APPOINTMENT OF OFWAT'S REPORTERS

Each water company is required under its licence conditions to appoint a reporter. Ofwat approves each appointment. The reporters are individual professionals who scrutinise water companies' annual returns and business plan information and give their opinion of it in a report to Ofwat. They have a primary duty of care to Ofwat, and also have a duty of care to the water company. The reporters' work is described more fully in Ofwat's Information Note 28, and in the reporter protocol MD 185.
