Water Industry Act 1991 Section 8(3)

Proposal by the Water Services Regulation Authority (Ofwat) to vary the appointments of SSE Water and Wessex Water as water and sewerage companies

This notice is a consultation on this proposal. The consultation period will last for 28 days. Having considered any representations submitted in response to the consultation, Ofwat will decide whether or not to grant the variations to these companies' appointments.

The Site

SSE Water has applied to be the water and sewerage services company for a development of 44 household properties at a site called Castle Way, in Salisbury (the Site). The Site is at present within the Water Supply Area and the Sewerage Services Area of Wessex Water.

The proposal

Ofwat proposes to:

- vary the appointment of SSE Water as a water and sewerage company by adding the Site to its Water Supply and Sewerage Services Areas; and
- vary the appointment of Wessex Water as a water and sewerage company by excluding the Site from its Water Supply Area and its Sewerage Services Area.

By means of these variations, SSE Water will become the water and sewerage supplier for the Site.

Policy for new appointments and variations

The new appointment and variation mechanism, set out in primary law¹, provides an opportunity for entry and expansion into the water and sewerage sectors by allowing one company to replace the existing appointee as the provider of water and / or sewerage services for a specific area. This mechanism can be used by new companies to enter the market and by existing appointees to expand their businesses.

When considering applications for new appointments and variations, Ofwat operates within the statutory framework set out by Parliament, including our statutory duty to protect consumers, wherever appropriate by promoting effective competition. In particular, in relation to unserved sites, we consider that we must ensure that the future customers on a site – who do not have a choice of supplier – are adequately protected. When assessing applications for new appointments and variations, the two key policy principles we apply are that:

1. customers, or future customers, should be no worse off than if the site had been supplied by the existing appointee; and
2. Ofwat must be satisfied that an applicant will be able to finance the proper carrying out of its functions as a water and/or sewerage company.

We clarified these two policy principles in February 2011 when we published our 'New appointments and variations – a statement on our [policy](#) and [process](#) for new appointments and variations'. In November 2012, we published '[Statement on our approach for assessing financial viability of applications for new appointments and variations](#)'. This states that we will adopt a company-based assessment of financial viability, rather than a detailed site-based assessment, where it is appropriate to do so.

When we assess whether customers will be no worse off as a result of the appointment, we not only consider the customers on the site but also the generality of customers. These include not only the customers of the existing provider but also customers more generally across England and Wales, who in our view benefit from the effective operation of the new appointment and variation mechanism.

¹ The legal framework for new appointments is set out in the Water Industry Act 1991 (WIA91). Section 7 of the WIA91 sets out the criteria by which an appointment or variation may be made. Section 8 sets out the procedure for making that appointment or variation.

The application

SSE Water has applied to be the water and sewerage company for the Site under section 7(4)(a) Water Industry Act 1991, which allows us to grant a variation if the incumbent undertaker consents (the consent criterion). In this case Wessex Water has consented to SSE Water's application. SSE Water is already the water and sewerage undertaker for a directly adjacent site called Old Sarum. When Ofwat granted SSE Water its initial appointment as a water and sewerage undertaker in October 2007, it was to serve 935 new household customers at the Old Sarum site.

Protecting customers

Ofwat acts to protect consumers, especially those who are unable to choose their supplier. In assessing applications to supply new development sites, Ofwat acts on behalf of end-customers who are not yet on site to protect their interests. The fact that future customers on the Site have not directly chosen SSE Water to be their supplier is not a position unique to new appointments – very few customers in England and Wales are able to choose their supplier².

Recognising this, our assessment of applicants' proposals includes analysis of their plans to ensure customers will be at least no worse off in terms of their annual bills and levels of service than if they had been supplied by the existing appointee. We will continue to protect customers on the Site by regulating the new appointee's prices and service levels.

Customers on the Site - price

SSE Water will take a bulk supply of water from Wessex Water to serve the Site and will discharge from the Site into Wessex Water's sewers.

² The only customers that can choose their supplier are non-household customers that consume at least 5MI per year and are supplied by a company that is wholly or mainly in England (and at least 50MI for companies wholly or mainly in Wales) and satisfy the Water Supply Licensing (WSL) eligibility criteria. Those non-household customers that consume at least 50 MI in England (and at least 250 MI in Wales) can switch under either the WSL or NAV regime.

SSE Water will match the existing metered water and sewerage household tariffs of Wessex Water. SSE is not offering a discount on these tariffs. The WaterSure tariff will be available to those customers that apply and qualify for it³.

Having considered SSE Water's pricing proposals, we are satisfied that customers will be at least no worse off in terms of their annual bills than if they had been served by Wessex Water.

Currently, SSE Water's conditions of appointment provide that SSE Water's price limit is set by reference to the charges of the previous providers for each of its sites. In this case, SSE Water may not charge customers on the Site more than Wessex Water's charges. We consider that, given SSE Water's small size, this represents a more proportionate way of regulating its prices than subjecting it to a full bespoke price review as we do for larger companies. However, condition B of SSE Water's conditions of appointment allows us to set a specific price limit for SSE Water. This condition is temporarily suspended but we will activate it when we consider it is appropriate to do so.

Customers on the Site - levels of service

SSE Water will be subject to the same customer service level requirements as other water and sewerage appointees.

Guaranteed Standards Scheme (GSS) compliance and base service levels

SSE Water has submitted information about its proposed service levels, under:

- the statutory requirements of the GSS Regulations;
- our service indicators; and
- its own company standards.

We have assessed these planned levels of service and are satisfied that they match or exceed those typically achieved by Wessex Water and the sector as a whole.

³ Through the WaterSure scheme, households on meters who receive certain means tested benefits or tax credits, and are either responsible for three or more children under the age of 19, or have a medical condition which requires significant additional use of water, can apply to pay no more than the average household bill for their region.

Codes of Practice

Every appointee is required under conditions G, H and I of its conditions of appointment to publish debt, leakage and customer Codes of Practice. We have assessed SSE Water's Codes of Practice, and are content that these are of an approvable standard so customers on the Site would be no worse off.

SSE Water's voluntary standards

We require that SSE Water matches or exceeds Wessex Water's own standards (except where there is reasonable justification for not doing so).

Examples of where SSE Water will offer improved customer service compared with Wessex Water include:

- SSE Water offers 0800 freephone numbers for all customer contacts, while Wessex Water's are 0345 numbers.
- SSE Water's call centre opening hours are longer than Wessex Water's. Wessex Water offers 8am-6pm Monday to Friday for billing and operational enquiries; whereas SSE Water offers 8am-8pm Monday to Friday and 8am-2pm on Saturday. Both have 24-hour lines for emergencies.
- SSE Water will make a higher GSS payment of £50 to domestic customers for a missed appointment, compared with Wessex Water's £35 payment in each case.
- SSE Water offers some additional standards which Wessex Water does not offer, such as offering customers a £5 credit when SSE asks them to run their tap when there is water discolouration; and it will pay £25 to customers if it fails to discuss access arrangements with the customer when they need access to that customer's property in advance of work commencing.
- SSE Water will also make higher payments for failures not covered by GSS, for example SSE Water pay £150 if a county court claim is made incorrectly, compared with Wessex Water's £100.
- SSE offers a more generous penalty payment whenever they fail to make a GSS payment in the allowed time. This is a £35 payment for all failures to pay, as opposed to Wessex Water who pay £20.

However, SSE Water does not propose to match Wessex Water in some ways, for example:

- SSE Water does not currently offer such an extensive range of services as Wessex Water for customers with special needs. For example Wessex Water

offers interpreter service, offers leaflets/bills on audio tape or CD and home visits.

- SSE Water does not offer as extensive a range of payment options as Wessex Water, although the range it does offer is adequate. SSE has signalled its intention to expand this range in future.
- SSE Water offers more limited ways for customers to contact it than Wessex Water. For example Wessex Water has a 24 hour automated bill payment line, however the opening hours for SSE Water's bill enquiries lines are longer than Wessex Water's.
- Wessex Water offers some additional standards that SSE does not, such as paying £35 to customers if they fail to send any requested literature in 10 days and paying £35 to customers if they fail to discuss any access issues with customers before starting work near to their property.
- SSE Water does not currently have a charitable trust fund, which Wessex Water does. Wessex Water also has an affordability tariff (Assist tariff). However, several other incumbents do not offer a charitable trust, assistance funds or affordability tariffs.

While the areas in which SSE Water does not propose to match Wessex Water are not statutory or appointment requirements, we have explained to SSE Water that these areas must be kept under review as its customer base expands. SSE Water has committed to do so. As SSE Water extends into different existing appointees' areas, all Codes will be assessed against other existing appointees' policies and we will request improvements we judge are required as its customer base grows.

Having considered SSE Water's overall proposed service levels, and compared them with those of Wessex Water, we are satisfied that customers on the Site will receive a level of service that is comparable with the level of service that they would have received had they been served by Wessex Water.

Wessex Water's existing customers

In considering whether customers will be no worse off, we also considered the potential effects of this variation on the prices that Wessex Water's existing customer base may face.

The calculation necessarily depends on a range of assumptions, and there are clearly difficulties involved in quantifying the effect. It is therefore necessary to use a simplified set of figures. We have expressed the effect in 'per bill' terms to try and quantify the possible effect in an easily understandable way.

Broadly, we have assessed the potential magnitude of this impact by comparing how much Wessex Water might have expected to receive in revenue from serving the Site directly, with the revenues it might expect to receive from serving the Site indirectly via bulk supply and discharge agreements with SSE Water. The lower bound of the range takes into account the benefit to Wessex Water as a result of SSE Water serving the Site, by estimating the costs that Wessex Water is likely to avoid, such as retail costs and capital and operating costs associated with the local network used to serve the Site. The upper bound of the range does not take these avoided costs into account. We look at these differences in revenue and costs over a hundred year timeframe to reflect the long life of the assets that will be used to supply customers at the Site.

In this case, we have calculated that if we grant the Site to SSE Water, there may be a potential impact on the bills of Wessex Water's existing customers of between £0.00 and £0.10.

We are comfortable that these ranges account for the uncertainty in the costs that may be avoided by Wessex Water. It is important to note that we do not have information on the level of developer contribution that Wessex Water would have received had it served the Site. We have therefore used data on the level of developer contribution that SSE Water will receive as a proxy. Generally, this will understate the level of developer contributions, as we might expect a new appointee to offer more attractive terms to a developer than an incumbent in order to win the new development.

Further, this impact does not take into account the potential spillover benefits to customers arising from dynamic efficiencies achieved as a result of the competitive process to win new sites. We set out the wider benefits we believe stem from the new appointments and variations regime below.

Developer choice

Ofwat takes into consideration the choices of the site developer. In this case, the Site developer has said that it wants SSE Water to be the water and sewerage company for the Site.

Environment Agency (EA) and Drinking Water Inspectorate (DWI)

We take the views of these organisations into account before progressing to consultation on an application for a new appointment or variation. Both EA and DWI informed us that they are content for us to consult on this application.

Wider benefits

The new appointment and variation mechanism provides a means for companies from outside the water and sewerage sectors to enter the market and for existing water and sewerage appointees to expand their businesses.

Entry and expansion (and even the threat of such by potential competitors) can lead to benefits for different customers in different ways (such as developers of new housing sites and household and non-household customers). Examples of benefits delivered via the new appointment and variation mechanism include price discounts, better services, environmental improvements and innovation in the way services are delivered. Benefits can also accrue to the existing appointee's customers, because when that appointee faces a challenge to its business that challenge can act as a spur for it to raise its game.

These wider benefits that we believe stem from the new appointments and variations regime are set out more fully in our [policy statement](#).

Overall assessment of effect on customers

Overall, we consider that customers on the Site will be at least no worse off with this Site being served by SSE Water than they would have been had the Site been served by Wessex Water. We consider that the potential effect on Wessex Water's existing customers is very likely to be offset by the wider benefits of the new appointment and variation mechanism. We are therefore satisfied that customers would be no worse off as a result of our granting this variation.

Ability to finance the proper carrying out of functions

We have a statutory duty to ensure that efficient appointees can finance the proper carrying out of their functions. When a company applies for a new appointment or variation, it must satisfy us that it is able to carry out all of the duties and obligations associated with being an appointed water or sewerage company.

In this case, SSE Water has satisfied us that it can finance its functions.

Conclusion and next steps

In assessing SSE Water's application for this variation, we have considered the general benefits of new appointments. We are satisfied that our two key policy

principles have been met in this case, as customers will be no worse off, and SSE Water will be able to finance its functions.

We have also considered the effects of granting this variation on the existing customers of Wessex Water.

We are therefore minded to grant the appointment under the consent criterion. We are consulting on our proposal to do so.
