Thank you for your email in which you request information concerning historical water charges and forecast charges.

Ofwat confirms it does hold some of the information requested.

Ofwat was not established until 1989 with the privatisation of the water industry and is the economic regulator for England and Wales only. You may wish to view the document "<u>The Development of the Water Industry in England and Wales</u>" which gives an insight into the regional provision of services prior to Ofwat's establishment and for access to information that we do not hold.

Some of the information you have requested can be found publicly available on the National Archives website <u>here</u>. The listings archived are from the period 2008-2009 however, some of the information contained within the charges reports (household data) do refer to earlier data.

We also hold 16 pdf editions of a publication entitled "Water Facts", published by the Water Authorities Association and which also contain historical data in relation to charges. These are for the period 1985-2000. Unfortunately they are too large to

In respect of forecasting our Price Review of 2014 (PR14) forecasts for the period 2015-2020. PR 19 will be looking at charges for the period 2020-2025 although this has not yet commenced. We will not be forecasting to the period 2040 at PR 19. PR 14 information can be found here.

For your information water companies are also subject to the Environmental Information Regulations and may hold further information that may assist you with your research. The National Archives may also hold permanent records in respect of former authorities responsible for water charges in respect to specific regions and may also be of help.
