Thank you for the opportunity to respond to the consultation referenced. Dŵr Cymru Welsh Water (DCWW)'s response to the consultation is set out below. Overall we support the proposed market information publication requirements as a way of addressing one of the key barriers to facilitating better functioning markets in these areas – the lack of accessible and consistent information relevant to potential trading activity.

Q1: Do you consider that the information Ofwat are requiring companies to publish is helpful and will provide sufficient transparency in the i) bioresources market and ii) water resource, demand management and leakage services market to support their operation and development?
