Thank you for your request for information concerning staff pay and executive emoluments.

Ofwat confirms that some of the information you are requesting is not held in the format requested. Some of the information is publicly available in Ofwat's annual accounts.

In order to provide the information in the breakdown requested Ofwat would need to undertake a business objects report to be completed. Ofwat's finance team do not have the skills to undertake this process, as it is not part of their normal finance functions. Therefore Ofwat would need to commission a report from our outsourced provider and obtain a quote for this process. If you wish us to proceed with this quotation please inform us and we will respond accordingly after consultation with our provider. If you wish to refine your request then please also confirm this as soon as possible.

Compensation payments are provided in Ofwat's annual accounts and reports against salary bands per annum. (See staff note/remuneration report)

I have included the links to our annual accounts and reports from 2010-2017 for information as they contain staff information including senior managers pay bands and expenditure by Ofwat, including pension information. Ofwat's annual report 2017-2018 is currently being written and will be published on our website shortly.
