1. About this document

Water Partners Limited (“**Water Partners**”), a registered company with company number 10772604, whose contact address is at Unit 41, Henfield Business Park, Shoreham Road, Henfield, West Sussex, England, BN5 9SL, has applied for a water supply licence and sewerage licence (“**WSSL**”).

This document provides notice of the application.

2. The application

On 9 October 2020, Water Partners applied for a water supply licence and sewerage licence with the following authorisations:

- Retail (water) authorisation;
- Retail (sewerage) authorisation; and
- Restricted retail authorisation.

If granted, this will enable Water Partners to provide retail services to eligible premises within the water retail market in England and Wales and to provide retail services to eligible premises within the sewerage retail market in England.

2.1 Synopsis of the business plan

Water Partners plans to offer water and sewerage services primarily by using third party intermediaries to identify customers in the English and Welsh markets. The focus will be on providing technical and consultative services to business customers.
