Thank you for your request for the following information which was received by Ofwat on 1st April.

'Good morning, I wonder can you help me in connection with water companies preparation and presentation of Drainage Strategies. I have read with interest the jointly commissioned document prepared by Halcrow Limited for both you and the EA.

I was wondering if there are any regulations governing the submission of these strategies from the water companies. In particular the frequency of submission and revision of the strategies would be of interest to me and also to know if it is mandatory to produce a strategy for all STW's. It may be that STW's with a P/E below a certain number may be exempt.

Anything you might be able to do to help me would be much appreciated. If outside the remit of OfWAT an indication of which body might be responsible for the regulation of Drainage Strategies would suffice.'

Although Ofwat are involved in this work, it is Defra who are ultimately responsible for setting out requirements for drainage and wastewater management plans (DWMPs). Defra published a summary of consultation responses and the Government's response in July 2019. The link to the document is here:

This makes it clear that the stated intent is to make DWMPs a statutory requirement – see page 25 where it states *“The government intends to proceed with the proposal to place Drainage and Wastewater Management Plans on a statutory footing, produced on a 5-year cycle.”*

The Environment Bill 2019-21, as introduced, includes the necessary amendments to the Water Industry Act 1991 to bring this about – see <https://publications.parliament.uk/pa/bills/cbill/58-01/0009/20009.pdf>
