# Strategic regional water resource solution: gate two draft decision for Southern Water

I am writing to inform you of our draft decision in respect of the following strategic regional water resource solution:

• Thames Water to Southern Water Transfer

As agreed in <u>RAPID's letter sent 27 May 2022</u> Southern Water are no longer involved in the Poole Effluent Recycling and Transfers and the Cheddar 2 Source and Transfers solutions.

The RAPID partner regulators would like to thank Southern Water for its submission timeliness, collaborative approach and positive engagement which has helped drive the quality and speed of progression of this solution.

This letter should be read in conjunction with the draft decision documents for these solutions, which were published alongside this letter. Both this letter and the draft decision documents were published on our website on 30 March 2023.

Following the publication of our draft decision, solution owners and other interested parties have the opportunity to respond to the draft decision. Representations are invited by email to <a href="mailto:rapid@ofwat.gov.uk">rapid@ofwat.gov.uk</a> and the representation period will close at 6pm on 11 May 2023. All representations will be considered before our final decision, which we intend to publish at 10am on 28 June 2023.

Where we have identified issues requiring urgent remediation, we expect the solution owners to resolve them to a suitable quality no later than the dates provided in the Appendix to each draft decision document.

## Solutions funded in PR19 final determination

The table below summarises the elements of our draft decision in respect of the Southern Water-sponsored solution. Further details are contained in the accompanying draft decision documents.

# Solution progress and funding

Funding allowance is detailed in Table 3 in the draft decision document for each solution.

Funding is allowed for the Thames Water to Southern Water Transfer to continue to be developed to gate three.

The following options are to continue to be investigated:

- Option B West of the A34 at Drayton, west of Newbury, remaining west of the A34 to Winchester
- Option C West of the A34 at Drayton, west of Newbury, crossing over the A34 to Winchester

The following options are not to continue to be investigated as part of the RAPID process:

- Option A West of the A34 at Drayton, west around Swindon to Winchester
- Option D West of the A34 at Drayton, east of Newbury, crossing over the A34 to Winchester
- Option E Between Reading and Pangbourne, south westwards via Basingstoke to Winchester

# **Evidence of efficient expenditure**

We determine that all expenditure on this solution is efficient and appropriate, and we allow it in full. The efficient costs allowance for the solution is given below.

• Thames Water to Southern Water Transfer - £2.17 million

### Submission quality

Our overall classification of the submission for the Thames Water to Southern Water Transfer is that it is "Good (meets expectations)".

#### Remediation

A list of remediation issues is provided in Appendix A of the draft decision document divided into priority actions, actions and recommendations. Priority actions are those that should have been completed at gate two and must now be addressed on a short timescale in order to make sure a solution stays on track.

We have also identified actions that should be completed in full in the gate three submission or at an alternative or earlier date where shown in Appendix A of the draft decision document. The response to these actions will influence the assessment of the gate three submission.

Recommendations relate to issues where additional information or clarification could improve the quality of future submissions.

We have not identified any priority actions in respect of the Thames Water to Southern Water Transfer and therefore Southern Water.
