

Variation of Icosa Water Services Limited's appointment to include North Shore Road (Phase 4 and 5), Stockton-on-Tees

On 3 July 2023, Ofwat began a [consultation](#) on a proposal to vary Icosa Water Services Limited's ("Icosa Water") appointment to become the water services provider for a development in Northumbrian Water Limited's ("Northumbrian Water") water supply area called North Shore Road (Phase 4 and 5), Stockton-on-Tees ("the Site"). Details of the application and our assessment of it were set out in the consultation document.

The consultation ended on 1 August 2023. During the consultation period, we did not receive any representations. Ofwat has engaged with the Environment Agency as part of the application process. For this application, the Environment Agency have flagged a potential risk of supply deficit. Where a risk of deficit exists, applicants are expected to assure the Environment Agency, via statutory processes, that there is not a risk of deficit or, that any deficit will be resolved. The risk has been flagged to Icosa Water to action and on 5 December 2023, the Environment Agency advised they have no further comments or objections and are happy for us to proceed.

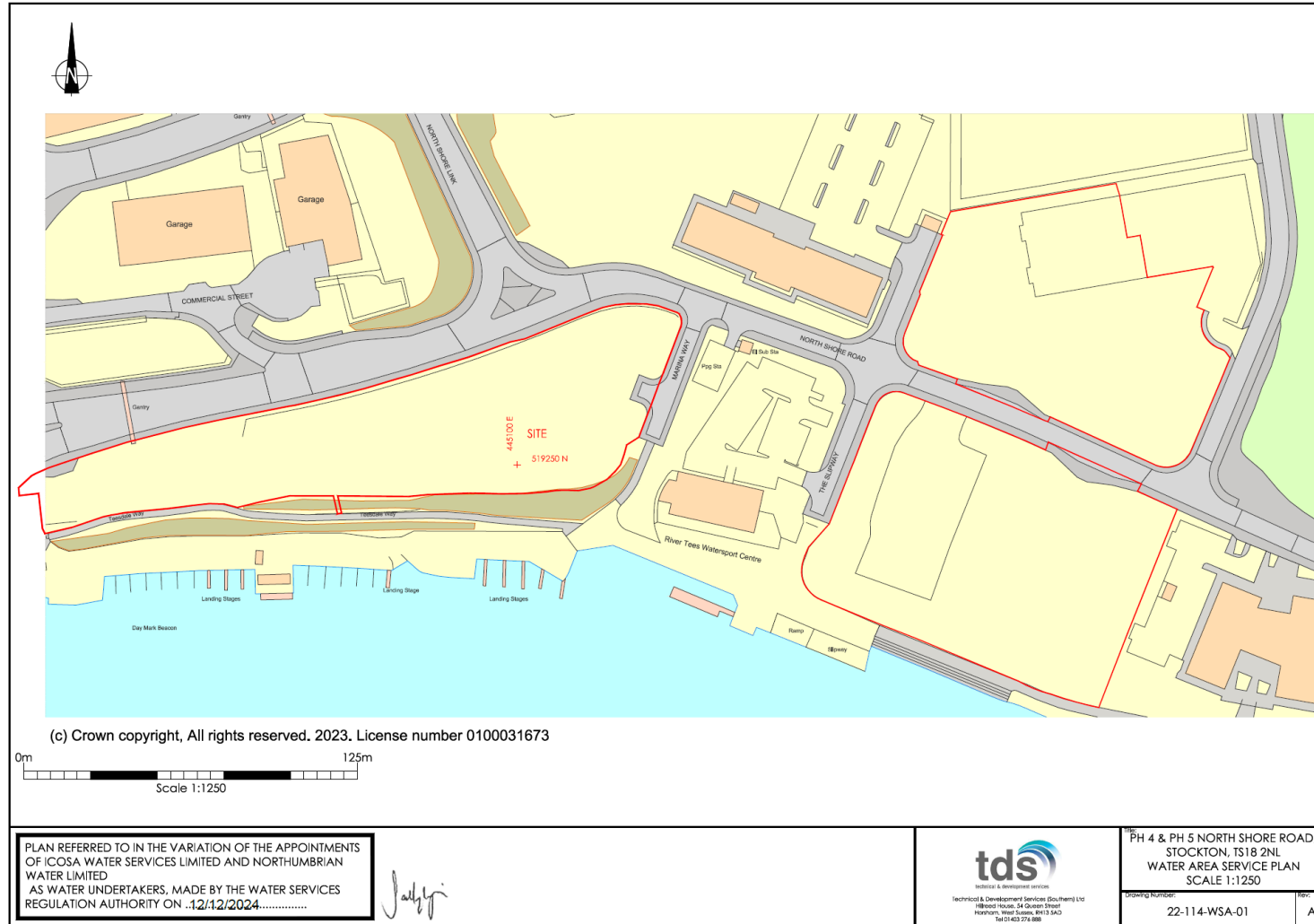
We will only make an appointment or variation if our assessment concludes that the application meets the criterion it has been made under; that customers or future customers on the site will be no worse off than if the site had been served by the existing appointee; and if the applicant will be able to finance the proper carrying out of its functions as a water company. As set out in our consultation we are satisfied this is the case.

Having assessed Independent Water Networks' application and having received no responses to our consultation, we decided to grant a variation to Independent Water Networks' area of appointment to allow it to serve the Site for water services. This appointment became effective on 13 December 2023.

WATER SERVICES REGULATION AUTHORITY
WATER INDUSTRY ACT 1991, SECTIONS 6 TO 9

Variation of the Appointments of Icosa Water Services Limited and Northumbrian Water Limited as Water Undertakers

Made on 12 December 2023

Coming into effect on 13 December 2023

1. Icosa Water Services Limited ("Icosa Water") and Northumbrian Water Limited ("Northumbrian Water") hold Appointments as water undertakers for their respective areas ("the Appointments").¹ The areas to which the Appointments of Icosa Water and Northumbrian Water as water undertakers relate ("Water Supply Area") are set out in their Instruments of Appointment.
2. The site called North Shore Road (Phase 4 and 5), Stockton-on-Tees, which is shown edged in red on the plan attached to this variation, ("the Site") is within Northumbrian Water's Water Supply Area. The Site is being developed by Lovell Partnerships Limited.
3. Icosa Water has applied under section 7(4)(b) of the Water Industry Act 1991 ("the Act") for a variation of its Appointment as a water undertaker to include the Site and for a consequential variation of Northumbrian Water's Appointment to exclude the Site.
4. On 27 June 1995, the Secretary of State for the Environment and the Secretary of State for Wales acting jointly and pursuant to sections 6(1) and 7(2) of the Act authorised the Director General of Water Services² to make variations such as those contained in paragraph 5 below. After public consultation, as required by section 8 of the Act, the Water Services Regulation Authority has decided that it should grant Icosa Water's application.
5. Therefore, as provided by sections 7(2) and 7(4)(b) of the Act, and with the agreement of Lovell Partnerships Limited, the Water Services Regulation Authority **varies**—

(a) the Appointment of Icosa Water as a water undertaker so that the Site is included in Icosa Water's Water Supply Area; and

(b) the Appointment of Northumbrian Water as a water undertaker so that the Site is excluded from Northumbrian Water's Water Supply Area.
