Condition B: Charges, is amended as follows:

- 1. In sub-paragraph 9.4(2), substitute "1 April 2025 to 31 March 2030" for "1 April 2020 to 31 March 2025".
- 2. In sub-paragraph 9.4(2A), substitute "1 April 2025 and ending on 31 March 2030" for "1 April 2020 and ending on 31 March 2025".
- 3. In sub-paragraph 9.4A(1A), substitute "1 April 2030" for "1 April 2025".
- 4. In sub-paragraph 9.4A(3), substitute "31 March 2030" for "31 March 2025".
- 5. In sub-paragraph 9.6A:
 - (a) substitute "on 31 March 2030" for "on 31 March 2025";
 - (b) substitute "1 April 2030" for "1 April 2025", in both places; and
 - (c) substitute "1 April 2025 to 31 March 2030" for "1 April 2020 to 31 March 2025."
- 6. In sub-paragraph 9.7(2):
 - (a) substitute "31 December 2029" for "31 December 2024"; and
 - (b) substitute "31 March 2030" for "31 March 2025."
- 7. Part VIII (paragraph 20) is deleted and replaced with the following text:

"Part VIII. Price Controls in effect before 1 April 2025

- The provisions of Condition B of this instrument in the form that had effect immediately prior to **7 May 2024** shall continue to have effect in respect of the Price Controls set for a period ending before 1 April 2025 and in respect of the making of any Interim Determinations to set any such Price Controls.
- In the event that the Water Services Regulation Authority is, in respect of the Appointed Business, unable to determine Price Controls, for the period or periods starting on 1 April 2025, under sub-paragraph 9.3 and sub-paragraph 9.4 of this Condition B by 31 December 2024, sub-paragraph 9.7(2)(b) shall have effect as if it provided that:

"the previous determination pursuant to sub-paragraph 9.4(2A) in respect of the Charging Year ending on 31 March 2025 shall continue to apply for consecutive Charging Years until the next relevant determination under sub-paragraph 9.4(2A) (or equivalent determination by the Competition and Markets Authority pursuant to paragraph 16) or the next relevant Interim Determination becomes effective:"".
