Variation of Independent Water Networks Limited's appointment to include Bradley Villa Farm, Huddersfield, West Yorkshire

On 22 November 2023, Ofwat began a <u>consultation</u> on a proposal to vary Independent Water Networks Limited's ("**Independent Water Networks**") appointment to become the water and sewerage services provider for a development in Yorkshire Water Services Limited's ("**Yorkshire Water**") water supply area and sewerage services area called Bradley Villa Farm, Huddersfield, West Yorkshire ("**the Site**"). Details of the application and our assessment of it were set out in the consultation document.

The consultation ended on 20 December 2023. During the consultation period, we did not receive any representations.

On 18 December 2023 Independent Water Networks notified us that it wished to amend details in its application to increase the number of household properties to be served on the Site from 270 to 277. Independent Water Networks advised these additional plots would be within the existing Site's boundary, which we consulted on, and it provided a revised financial model to reflect the additional properties.

As the consultation for this application concluded on 20 December 2023, we notified the statutory stakeholders of the change on 8 January 2024 and allowed a further five working days, until 15 January 2024, for any new representations to be made. We received no further comments. We reassessed the financial viability of the Site following the increase in customer numbers on the Site and we remain satisfied that Independent Water Networks will be able to finance its functions if this variation is granted.


We will only make an appointment or variation if our assessment concludes that the application meets the criterion it has been made under; that customers or future customers on the site will be no worse off than if the site had been served by the existing appointee; and if the applicant will be able to finance the proper carrying out of its functions as a water and/or sewerage company. As set out in our consultation we are satisfied this is the case.

Having assessed Independent Water Networks' application and having received no responses to our consultation, we decided to grant a variation to Independent Water Networks' area of appointment to allow it to serve the Site for water and sewerage services. This appointment became effective on 8 February 2024.




